

MASK ORDER REMAINS IN EFFECT IN MUNICIPAL BUILDINGS

The Mask Order issued September 29, 2021 remains in effect for all municipal buildings. This Order was put into place due to the increase in COVID-19 cases that began in September and has continued ever since. The Delta variant and the Omicron variant of the COVID-19 virus have become increasingly prevalent in Massachusetts, throughout the United States and beyond. The Centers for Disease Control (CDC) have released updated guidance on the need for urgently increasing COVID-19 vaccination coverage and a recommendation for everyone in areas of sub-



stantial or high transmission to wear a mask in public indoor places, even if they are fully vaccinated. Additionally, the State Department of Public Health has a mask advisory in place.

While many individuals have been fully vaccinated, our overall vaccination rate in Auburn is 68%. The Board of Health continues to encourage all individuals to get fully vaccinated and boosted. We have seen many breakthrough cases, although most of those cases are not severe, and some have impacted our government operations, so we remain vigilant to try to reduce the risk of spread of this virus.

to prevent or minimize the spread of the Delta and other emerging variants by and among Town employees and visitors to Auburn municipal buildings. As a result, the Board of Health voted to mandate that all persons, employees and visitors, wear a face covering when inside any municipal building where six (6) foot social distancing cannot be met.

The Town Manager then issued a Mask Order for all municipal buildings with the following

1. All town employees in departments under the Town Manager shall wear a face covering

- while in the performance of their official duties, whether in a town building or working in a non-town building where six (6) foot social distancing cannot be met, regardless of vaccination status.
- tion status.

 2. All visitors to municipal buildings over the age of two must wear face coverings while inside municipal buildings where six (6) foot social distancing cannot be met. This includes Town Hall, Library, Senior Center, Department of Public Works, Pakachoag Golf Course

Clubhouse, Police Station, and Fire Station or any indoor location where a town program or

event is held.

3. Employees may remove the face covering while in the employee's own private office, provided that the employee is alone. Employees in shared workspaces must wear face coverings where six (6) foot social distancing cannot be met.

4. Social distancing should be practiced in offices and when interacting with the public, espe-

cially in break rooms and areas where employees are eating and drinking. When possible, department heads should stagger employee breaks to reduce occupancy in shared break

5. When two or more employees are inside a town vehicle, the employees shall wear a face covering. Face coverings are not required when employees are alone in town vehicles.

 The Mask Order will remain in effect whenever the Level of Community Transmission data

This mandate will no longer be in effect whenever the Level of Community Transmission data from the US Centers for Disease Control (CDC) for Worcester County is categorized as either "Low" or "Moderate" over a consecutive two week period.
- Please respect the mask order, and be mindful to keep a safe distance away from others you are interacting with in municipal buildings.
- The Town would like to thank you for your cooperation in keeping yourself and others safe during this challenging time. We all have a responsibility to protect our health and those around us, and to do our part to move us out of this pandemic.



2022 CENSUS



CENSUS:

2022 Annual Street Listing forms will be mailed at the beginning of January. Please fill out, sign and return promptly even if there a no changes. If someone living in your household has moved you may indicate that, if they are a registered voter they must sign to be removed. There is a line for any moved household members to sign or give the address we will mail a form for them to sign at their new address. Voters are made inactive in June of each year if the census is not updated. This creates long lines at elections when a voter is

made inactive. Then the voter must fill out a form and provide proof that they still live at their Auburn address. The signed census forms can be mailed back in the return envelope, dropped off, or scanned and emailed back: townclerkemail@town.auburn.ma.us

DOG LICENSING

On the bottom of the census form is a dog license form for 2022. To license by mail, fill out the form and enclose a check to cover the fee. Registration Period is January 1, 2022—March 31, 2022. Town bylaw imposes a \$10.00 late fee per dog if not licensed by April 30, 2022. If you would prefer to license on-line please use: https://www.mapsonline.net/auburnma/dog_licensing If you have licensed a dog in the past you will be able to license with this link, provided your rabies is up to date. Any person seventy (70) years of age or older, upon proof of age and ownership shall be exempt from the annual fee for one dog, per household, per year.

Please be aware that as of January 1st, 2022, there will be a fee increase for delinquent dog accounts for annual dog licensing. It is important to note that this increase will NOT affect any owners who license on time or within the same calendar year of the licensing due date. This delinquency fee will ONLY affect owners who have failed to previously license for a full calendar year or longer. If you no longer have your dog, you must report that information to the Town Clerk's Office so your dog can be removed from the system. Because of re-districting, all Town Meeting Members must run for election. The first third of members elected in order of votes received will serve three years. The second third will serve for two years. And the remaining third of the 24 will serve for one year from the day of the annual election.

JULIA BANCROFT—COMING SOON!



Julia Bancroft Apartments is a mixed-income community for seniors 62 and older currently under construction in Auburn, MA. The 60-unit community will offer studio, one- and two-bedroom apartment homes. The historic redevelopment plan of the school building includes the renovation of the historic school, demolition of later built additions, and construction of a new addition. The brand-new community will include inviting resident spaces, fitness center, two outdoor patios, on-site laundry facilities, and more.

Occupancy is currently slated for Summer 2022. A lottery will be held for the apartments by the owners, Pennrose Properties. For the initial lease-up, households who live, work, or have children that go to school in Auburn will have a preference in the lottery for 70% of the apartments.

WHAT DO TOWN PLANNERS DO?


The Town Planner provides technical and administrative support to the Planning Board by

reviewing and making recommendations on development proposals, and assisting landowners and developers with the development process. The Town Planner is also responsible for the updating of the Town's Zoning Bylaw, Master Plan, and Open Space Plan. These documents aid in shaping development in the Town in a manner consistent with the residents desires as well as best planning practices. Planners have all kinds of different skills and knowledge, a great way to explain what a town planner does is they are a true Jack of All Trades. Some skills necessary include development assessment, strategic planning, policy planning, community and stakeholder engagement, and land use planning all while contemplating the environmental, social and economic outcomes. Planners identify the strategies by which the community can reach its goals and vision. Planners are also responsible for the implementation or enforcement of many of the strategies,

often coordinating the work of many groups of people. It is important to recognize that a plan can take a variety of forms including: policy recommendations, community action plans, comprehensive plans, neighborhood plans, regulatory and incentive strategies, or historic preservation plans. ZONING BYLAW UPDATES



number of zoning bylaw amendments at Town Meeting on October 26th. The approved zoning bylaw amendments will help Auburn remain competitive for commercial development. The proposed zoning bylaw warrant articles included increasing maximum building heights in commercial and industrial zones, adding and/or amending the description of uses and updating the zoning bylaw use chart. Appropriate zoning is essential to community development because it dictates land usage. Building communities that "work" - inclusive, healthy, resilient,

and sustainable – requires intensive policy coordination and investment choices. There has not been a complete substantial update to the zoning bylaws since 1941 in Auburn.

The Town of Auburn Economic Development Strategic Plan, completed in 2017, outlines a number of strengths, weaknesses and strategies to help facilitate economic development in Auburn. Much of the report identifies a need to review the current zoning bylaws and make strategic changes consistent with economic development opportunities; including changes to height restrictions. Closely related, a few interviewees included in the report felt that outdated zoning designations may be the biggest deterrent to development in Auburn (Economic Dev. Plan pg. 20).

In the past 20 years, there has been an increasing desire for greater ceiling heights for warehouses and commercial buildings. Auburn currently allows a maximum building height of 35' in our industrial and commercial zones. Due to this restriction, the existing building heights are not always conducive to attracting more modern uses to Auburn (i.e. biotech, high-tech, modern distribution). Many of these modern uses are economic development incubators that bring higher paying jobs to the region. Recently, a number of surrounding towns changed their height restrictions due to demand. Sutton, MA recently approved a maximum height of 70'. Charlton recently changed their maximum height to 75' (up to 110' with special permit). Oxford, Upton, Millbury, Spencer, Uxbridge, Leicester, Dudley and Webster all have maximum building heights of 45'-55', well over the allowable 35' in Auburn. Auburn cannot rely on location alone to attract business anymore. Auburn has some of the lowest building height for commercial and industrial areas and limited available commercial land. Commercial investments helps generate revenue for Town services, creates new jobs and presents opportunities to improve infrastructure. Additionally, many commercial developments utilize and promote more sustainable and environmentally friendly features and practices. It is important to note that these bylaws will not allow 80' buildings in residential zones.

Town Administration has been working diligently the past few years to update our zoning bylaws to reflect the current commercial landscape of town while also encouraging more modern development. These changes wouldn't have been possible without Town Meeting support. Town Administration sincerely appreciates Town Meeting Members taking the time to hear the town's vision and voting in favor of the proposed zoning bylaw changes.

AUBURN BOARD OF HEALTH CONTINUES FIGHTING COVID-19

The Auburn Board of Health continues their effort to fight COVID-19, as we have done since the start of this pandemic nearly two years ago. This Fall, we began a wonderful partnership with the Auburn Pharmacy & Home Health Care, a local pharmacy in Auburn that has been serving the community in wellness for several years now. Seeing the need in Auburn for COVID booster vaccines, we planned and completed four vaccine clinics and administered over 1,200 shots to Auburn residents and beyond!! These weekend clinics were done with a team of staff and volunteers on the weekends through November and December, in an




effort to "booster" as many people as possible. In is our hope that this community work provides protection from the COVID virus/variants for the vaccinated individuals at their family gatherings this holiday season! These clinics were a momentous accomplishment for the Board of Health and Auburn Pharmacy team. This partnership bridged the opportunity to extend our joint efforts to offer a Pediatric Clinic.

During the week of Christmas, the Board of Health and Auburn Pharmacy offered a Pediatric Pfizer COVID-19 Clinic for eligible children ages 5 through 11 at the Auburn High School. Close to 100 pediatric first shots were administered with minimal tears shed. This clinic was holiday themed. Staff working the clinic wore Santa hats and Jingle Bells to ease any woes in receiving a scary shot. There were sweet treats, col-

oring activities, and Christmas Classic movies playing, ready in the observation area for the children immediately after they braved their first COVID-19 vaccine shots. Of course, the star of the show was a Comfort Dog, named "Ellie" who provided emotional support to the schools.

Amid the ongoing pandemic, the spread of influenza is still a relevant concern. The Board of Health conducted our 3 annual flu vaccine clinics for Auburn Seniors, Town Employees and the




NATIONAL GRID FLEET ASSESSMENT

The Town recently completed a comprehensive fleet assessment with National Grid and ICF. The National Grid MA Fleet Advisory Services Program provides free, expert analysis to help municipalities understand how shifting publicly owned vehicle fleets to electric power sources can benefit your organization and your community.

The program assigns an expert advisor for electric fleet vehicles, conducts a thorough analysis of the town's existing fleet, provides a customized report and personalized recommendations and assists municipalities to find financial assistance to offset the costs of electric vehicles. This plan can be updated twice per year for free and the advisors are available to help guide municipalities as they implement electric vehicles into their fleet. The town is currently waiting to hear back from the State regarding a grant application for electric vehicle charging stations at Town Hall. The EVIP program covers up to 100% of the costs associated with purchasing and installing charging stations at municipal owned parcels. This report will help guide the town to hopefully secure additional future funding as well. The full report will be available on Auburnguide.com in January.

GREEN COMMUNITIES



Community Report to the state. The Town reminds committed to implementing energy saving strategies and looking for opportunities to upgrade outdated energy infrastructure to help offset raising energy costs. The annual report helps the State remain up to date with yearly energy usage, green energy initiatives and allows the town to apply for Green Community grants during the next fiscal year.

Reminder – Community Choice Power Supply Program

We all know energy costs are rising and that the winter weather can put a strain on household and business energy usage. Thankfully the Town selected Dynegy Energy Services as the supplier for our municipal aggregation program. This program enables local government to combine the purchasing power of its residents and businesses to provide them with an alternative to National Grid Basic Service. This program allows municipalities to take advantage of a fixed aggregation rate that helps prevent sharp increases of service rates due to weather and other factors. As a result of utilizing Dynegy Energy as the supplier, the Town is able to save residents and businesses money on their monthly electric bill. You are automatically enrolled into this program as long as you were a NGRID Basic Service member. If you are enrolled in the program you should see "Dynegy" listed under the "Supply Services" section of your monthly bill.

BUILDING DEPARTMENT



As we move into the winter months here in New England, the potential for heavy snowfall increases. Homeowners, tenants, and businesses should be cognizant of the danger posed by heavy snow loads on roofs, and the importance of recognizing the warning signs of potential structural weaknesses. In many instances, the risks posed by accumulated snow can be mitigated by safely removing snow

Flat and low-pitched

roofs, most often found on industrial buildings, but also used in certain home designs, are at the greatest risk of buckling under heavy snow and ice accumulations. Snow on roofs, particularly around gutters and soffits, also may contribute to ice dams and damage from water leaking into walls, ceilings, insulation and other areas.

To safely remove snow from roofs, the Massachusetts Department of Public Safety (DPS), the Department of Fire Services (DFS) and the Massachusetts Emergency Management Agency (MEMA) recommend the following tips:

DO

- Use a snow rake for pitched roofs (available at most hardware stores and home centers) to remove snow from your roof.
- Start from the edge and work your way into the roof.
- Try to shave the snow down to 2 or 3 inches on the roof instead of scraping the roof clean, which will risk damage to your shingles or other roof covering.
- Keep all ladders, shovels and roof rakes away from utility wires.
- Plastic shovels are usually best. Metal tools may cause damage to your roof.
- Shovel snow from flat roofs throwing the snow over the side, away from the building.
- Remove large icicles carefully if they're hanging over doorways and walkways. Consider knocking down icicles through windows using a broom stick.
- Protect gas and electric meters and piping from falling snow, icicles, and melting water.
- Wear protective headgear and goggles when performing any of these tasks.
- Consider hiring professionals to do the job. The combination of heights and ice makes
 this a dangerous household chore. If you choose to do the task yourself, have someone
 outside with you to assist.
- Keep gutters and drains clean, free of ice and snow and keep downspouts clean at ground level.

DO NOT

- Do not add your weight or the weight of equipment to the roof.
- Do not use a ladder since ice tends to build up on both the rungs of the ladder and the soles of your boots.
- Do not use blow torches, open-flame, electric heating devices, or heat guns to remove snow and ice.

How to Recognize Problems with Roofs

- Sagging roofs
- Severe roof leaks
- Cracked or split wood membersBends or ripples in supports
- Cracks in walls or masonry
- Sheared off screws from steel frames
- Sprinkler heads that have dropped down below ceiling tiles
- Doors that pop open
- Doors or windows that are difficult to open
- Bowed utility pipes or conduit attached at ceilingCreaking, cracking or popping sounds

What to Do if You Have Problems

- If you notice any signs that you have a problem with your roof, or suspect a gas leak, leave the building immediately without touching light switches and call 9-1-1 from safely outside the building.
- For general questions, call your local building or fire department business line.

Ice Dams

• Ice dams can cause major damage to a home or building. Ice dams occur after a heavy snowfall, followed by a period of cold weather. An ice dam is a wall of ice that forms at the edge of the roof, usually at the gutters or soffit. When it forms, the water backs up behind the ice dams and creates a pool of water which can leak into your home and cause damage to your walls, ceilings, insulation and other areas. Ice dams are caused, in part, by poor ventilation causing a temperature differential on the roof surface. To learn more, see the Preventing Ice Dams article from University of Massachusetts Amherst.

Other Safety Tips for Homeowners

- Clear snow away from furnace and dryer exhaust vents to prevent carbon monoxide poisoning. Make sure you have working smoke and carbon monoxide alarms on every level of your home.
- Clear snow from fire hydrants near your home or business.
- Clear snow from storm drains near your home or business to prevent street flooding.

WILDLIFE RESCUES



Animal Control is happy to share with you two successful wildlife rescues from November and December!

This Red-Tailed Hawk was picked up by Animal Control after being found on the ground in a resident's yard and unable to fly. The hawk was transferred to a local wildlife clinic for evaluation of injuries and treatment. The hawk required several weeks of treatment and rehabilitation but made a successful recovery!

While ACO Aimee Contois was out of the office, Darlene Coyle, Colleen Hynes, and Jordan Bruso of DDIS were able to release this now healthy bird back into the wilds of Auburn!

Successful release # 2 came in the form of a Canada Goose! This goose was picked up by Animal Control in mid-November after flying into the side of a mov-



ing vehicle. The goose was clearly disoriented after the accident but had no visible injuries. It spent the night with Animal Control but when it was still reserved and quiet the following morning, it was transferred to a local wildlife

clinic for evaluation and treatment.

This lucky goose required just under a month of treatment and rehabilitation before it was healthy and strong enough to be released back into the area it had been found in. We are happy to say it appears that its family had stayed in the area and so they could be successfully reunited!



NEW STORMWATER LAND DISTURBANCE REGULATIONS


The new regulations include requirements for enforcing removal of illicit discharges (aka pollution) into local water bodies, as well as establishing procedures for the application and review of land disturbance permits. A permit is required for the following activities:

- Any land disturbance activity equal to or greater than 5,000 square feet;
- Any land disturbance activity where there is an existing or proposed slope of 15% or greater AND disturbs equal to or greater than 2,500 square feet;
- Any land disturbance activity that will result in equal to or greater than 50 cubic yards of material filled, removed, or altered; and/or
- An increase of equal to or greater than 1,000 square feet of new impervious area

FLUSHING WIPES



What can go down the toilet? Only the three P's should be flushed: Poop, Pee and Paper (toilet paper only). Toilets are not trash cans! Even if a product is labeled "flushable" that does not mean that it will break down after being flushed like toilet paper does. Clogged sewer pipes, sewer backups, and equipment failure at wastewater treatment plants can impair the process and threaten our clean water goals. Protecting infrastructure also saves all of us a truckload of money.

Very few wipes dissolve like toilet paper, even "flushable" wipes. Spread the word! Inform your friends and family of the dangers of flushing wipes down the drain.

WHAT TO EXPECT DURING WINTER STORMS

During snow storms it is the Department of Public Works' top priority to keep people safe and roads passable. Because the conditions of each storm are different, staff work diligently to ensure the best use of finite staffing and equipment, but, in general, the following steps are taken:

- Depending on temperatures and the rate and duration of snowfall, salt is often applied prior to the start of the storm. This gives the salt a chance to work before plows come to remove snow.
- Once snow begins to accumulate, plowing operations begin and continue until the storm
- It takes 3 hours for 21 Town employees and multiple private contractors to complete one pass of the Town's approximately 200 lane miles of roads.
- At the completion of the storm, salt is applied a final time and plowing begins on the Town's approximately 14 municipal parking lots and 24 miles of sidewalk.

Snow plow drivers do their best to keep roads passable during the storm and then clear once the storm ends. Unfortunately, as snow is plowed off the streets, it piles up at the end of driveways. Due to the amount of snow, it is near impossible to prevent this from happening. Snow plow drivers work long hours before, during, and after a snow storm to clear as much roads as possible. Your patience, along with complying with the following guidelines, are always appreciated!

- Observe the Parking Ban (November 1st March 31st)
- Use reflectors to delineate areas of concern
- If possible, remove snow from around fire hydrants and drainage grates
- Stay off the roads during the storm, whenever possible, and don't crowd snow plows

WHAT TO EXPECT DURING SNOW STORMS



Reminder: The Auburn Parking Ban begins November 1st and lasts until March 31st. During that time, no vehicles may be parked within the travel way or sidewalks between the hours of 1:00 AM and 6:00 AM. Thank you for adhering to this rule, which, among other things, allows the Town to efficiently plow during snow storms. Additional information may be found in the Auburn General By-laws, Section 15.11.

RESIDENTIAL & COMMERCIAL SALT APPLICATION

Rock salt, or sodium chloride, is an essential part of keeping sidewalks and driveways safe during snowy conditions. However, chlorides can cause damage Winter Road Maintenance Tip to vehicles, infrastructure, and the environment, particularly the As an environmentally friendly alternative health of our local waterways. Avoiding over-application of salt is a great way to mitigate this damage. Always clear your walkways before snow turns to ice and before you apply salt. The more snow you clear manually, the less salt you'll need.

to road salt (sodium chloride), you should consider magnesium chloride to melt snow and ice

Remember a 12-ounce coffee mug full of salt is enough to treat a 20-foot driveway or 10 sidewalk squares!

CHIEF ROGER BELHUMEUR REGIONAL TRAINING FACILITY



On Saturday November 14, 2021 the AFRD was joined by federal, state and local politicians and administrators, other District 7 fire departments, family and friends to see the naming of the departments new training facility. Retired Fire Chief Roger Belhumeur passed away in 2015 and was a staunch supporter of regional training within the fire district and was one of the Chiefs who resurrected the defunct District 7 Mutual Aid Association in the early 1990's.

The new training facility that was constructed with a \$525,000 grant from the Federal Emergency Management Agencies, Assistance to Firefighters Grant program and \$120,000 that was willed to the department after longtime Auburn resident and friend of the AFRD Norma Card passed away in 2011. The new facility, the "Chief Roger Belhumeur Regional Training Facility" pays tribute to the man who was responsible for the construction of the departments first training facility at the same location on West St. in 1999. An additional plaque recognizing Norma is also affixed to the building.



We submitted two wreaths; one created by children who visited the Library, shown to the left. Twenty eight children decorated two miniature snowfriend faces with hats. One was for the wreath, and the other was to take home!



Hanover Theatre: We partnered with the Hanover Theatre Conservatory for the Performing Arts for a reading and dance presentation, *Clara and the Nutcracker Ballet*. Clara's reading of the *Nutcracker* mesmerized a capacity crowd of 18 children, after which the Director of the Theatre, Jennifer Agbay led the children through a lively and engaging discussion of the nuances of the story. Following the story and discussion, children were invited to learn steps of the dance, led by Clara, who also performed a solo dance and posed for photos with each

child. This was truly a unique opportunity, which we are already scheduling to repeat in 2022.







PROGRAMS

We held 31 well-attended in-house toddler programs over the past several months. In addition, we offered programs from Ted Reinstein for his new book *Beyond Brooklyn*; a three-session 'Tai chi Basics' program for adults; several in-house Prek-K programs; a hibernation-education program for children with Heather from Hands on Nature; Amanda Goodheart: *The Seven Sisters Go to War: American Women's Colleges During WW II*; and others.

Veteran Health Identification Card

When you're enrolled in VA health care, you get a Veteran Health Identification Card (VHIC) that you use to check in to your appointments at VA medical centers. You may also use this card to get discounts offered to Veterans at many stores, businesses, and restaurants. If you have a VHIC, you don't need to request another type of photo ID card to prove you're a Veteran or to get retail or business discounts.

Veteran Choice Card

When you receive care from a community provider through the VA Choice program, you get a form of ID called a Veteran Choice Card. To learn more about the Veteran Choice program, contact (866)606-8198.

Veteran ID Card

A Veteran ID Card (VIC) is a form of photo ID you can use to get discounts offered to Veterans at many stores, businesses, and restaurants. When you have this card, you won't need to carry your military discharge papers or share sensitive personal information to receive discounts. If you have a VIC, you don't need to request another type of photo ID card to prove you're a Veteran or to get retail or business discounts.

You may be eligible if you meet both of the requirements listed below:

- Served on active duty, in the Reserves, or in the National Guard (including the Coast Guard)
- Received an honorable or general discharge (under honorable conditions)
- *If you received an other than honorable, bad conduct, or dishonorable character of discharge, you're not eligible for a Veteran ID Card. If you have an uncharacterized or unknown discharge status, we'll have to verify your eligibility before we approve your application.

Veteran's designation on a state-issued driver's license, ID, & License Plates

At this time, all 50 states and Puerto Rico offer a Veteran designation printed on state-issued driver's licenses, Ids, and license plates. With a Veteran's designation, you may be able to get discounts offered to Veterans at many stores, businesses, and restaurants. Most states ask you to provide a copy of your discharge papers (DD214 or other separation documents). Please check with the Registry of Motor Vehicles about what you need to apply for a Veteran's designation.



Add your phone to the fight

MassNotify is a new tool that works through smartphones, with a focus on privacy, to alert users who may have been exposed to COVID-19. You can enable MassNotify on your iPhone or Android phone to add another tool to our fight against the spread of COVID-19.

This is how MassNotify works:

When two people using MassNotify on their smartphones are near each other, their phones exchange random codes using Bluetooth. The code is completely anonymous, with no location tracking or exchange of personal information.



When someone in Massachusetts tests positive, they will receive a text message from the Dept. of Public Health with a verification link.



The person who tests positive can follow the link to anonymously share their positive test result with other MassNotify users. This is voluntary.



Anyone who also has MassNotify and has been near the user who tested positive for a significant length of time in the last 14 days may receive an anonymous alert that they might have been exposed to COVID-19.





Notifications have a link to information about what to do next to protect yourself and others. They do not contain any information about who tested positive or where the exposure may have happened.
